MINIMUM QUALIFICATIONS: Graduation from an accredited Dental College. Extensive supervisory experience (72 months or more) in clinical dentistry, preferably in a mental health setting.

NECESSARY SPECIAL REQUIREMENTS: Possession of a license to practice dentistry as issued by the Alabama State Board of Dental Examiners.

KIND OF WORK: This is responsible administrative and professional dental work in directing the dental health program of a large state mental health facility. An employee in this class is responsible for the administration, supervision and coordination of the dental health program of Bryce Hospital as well as providing clinical services to patients for Harper Geriatric Facility and Taylor Hardin Secure Medical Facility. Perform all phases of general dentistry including: Periodontics, minor orthodontics, Prosthodontics, Endodontics, radiology, oral surgery and operative dentistry as licensed to perform by the State of Alabama. Participate in 24 hour-a-day 7 day-a-week dental emergency call. Meet requirements for membership on active Medical Staff. Work is performed with considerable latitude and professional discretion, and is reviewed by a professional or administrative supervisor through periodic and special reports and conferences.

REQUIRED KNOWLEDGES, SKILLS, and ABILITIES: Knowledge of Medicare, Medicaid and Joint Commission standards as it relates to dentistry. Ability to plan, organize and prioritize work activities. Ability to direct and review the work of others. Ability to be objective in all situations. Ability to interact with other professionals in a courteous and professional manner. Ability to communicate effectively both orally and in writing.

METHOD OF SELECTION: Applicants will be rated on the basis of an evaluation of their job related training, abilities, experience, and education, and should provide adequate work history identifying experiences related to the duties and minimum qualifications as mentioned above. All relevant information is subject to verification. **Drug screening and security clearances will be conducted on prospective applicants being given serious consideration for employment whose job requires direct contact with patients.**
