KIND OF WORK: This is a professional nursing position at a state mental health facility specializing in the care and treatment of elderly, mentally ill patients. A registered nurse in this position is: Responsible for the delivery of patient care through the nursing processes of assessing, planning, and evaluating the needs of patients; Participates in the processes of treatment planning, collaborating with other professional disciplines to ensure effective and efficient patient care delivery and the achievement of desired patient outcomes; Develops and implements patient care plans; Supervises and assigns the work of LPN's and unlicensed nursing staff; Attends meetings and inservices as required; and teaches and trains staff.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES: Ability to communicate effectively, orally and in writing. Knowledge, skills and ability to recognize medical and psychiatric emergencies. Ability to interact with various types of people, including patients, peers, subordinates, supervisors, public, etc., in delicate, frustrating or tense situations. Ability to make independent decisions, to take charge, to take moderate risks in situations not covered by existing procedure. Ability to provide care utilizing nursing process, standards of care and nursing plan of care. Ability to supervise the work of others, delegate, instruct, discipline, commend, and interview as needed to

evaluate staff performance, ensure completion of tasks as scheduled, assign work load, address complaints and orient new employees. Ability to evaluate effectiveness of treatment/training programs and establish priorities. Ability to operate medical equipment. Ability to provide education to patients.
