- Coordinates ongoing staff development programs for Therapeutic Recreation.
- Performs monthly assessments of recreation staff documentation to ensure treatment plans ar individualized, patient-specific, and updated as needed.

# REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:
