- Preference may be given to individuals with experience in a hospital setting.

#### NOTE:

• A Doctorate degree may substitute for up to 12 months of the responsible administrative experience. There will be no substitution for the forensic mental health services experience.

#### **KIND OF WORK:**

- Maintain operational control of all forensic evaluation services in facilities.
- Oversee the training of forensic evaluators.
- Develop and implement a quality control program for forensic evaluations, training, data collection, and coordination of services.
- Ensure the proper flow of information to/from the jails to/from ADMH for the purposes of streamlining admissions, ensuring continuity of care.
- Coordinate forensic services for individuals treated in hospitals inside the direct continuum of care of ADMH.
- Oversee the forensic data collection, analysis system, and dissemination of important data points or trends.
- Coordinate continued development and implementation of community based forensic services and programs.
- Coordinate alternative forensic services for individuals with significant cognitive impairments.
- Serve as part of the team created by ADMH to assess the need for additional mental health personnel, beds, and additional resources necessary to ensure compliance.

• Perform additional duties and responsibilities as necessary to effectuate the requirements of a working system-wide forensic care system.

# **REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:**

- Knowledge of administration and management in the forensic mental health field.
- Knowledge of the philosophies and needs of both the mental health and criminal justice systems.
- Knowledge of principles, methods, and techniques related to the assessment of incompetency to stand trial and mental status at the time of offense.
- Knowledge of recent developments in the field of mental health forensics.
- Knowledge of laws, rules, and regulations to include The Joint Commission, Medicaid, Medicare, Rules of Criminal Procedure, and the Code of Alabama.
- Ability to facilitate the development of programs and services resulting in seamless transition of consumers under criminal court commitment, from inpatient to community care.
- Ability to direct the work of professional and administrative employees engaged in the management and operation of inpatient services for forensic patients and outpatient forensic evaluations.
- Ability to establish and maintain effective working relationships with subordinates, associates, and representatives of other departmental and government agencies.
- Ability to effectively communicate in a clear and concise manner, both verbally and in writing.
- Ability to analyze financial operations and improve operational efficiencies.
- Ability to budget operations and maintain operations within approved allotted budget.
- Ability to react quickly and calmly in emergency situations.
- Ability to use a personal computer, Microsoft Office software, and the internet.

**METHOD OF SELECTION:** Applicants will be rated based on an evaluation of their education, training, and experience and should provide adequate work history identifying experiences related to duties and minimum qualifications as mentioned above. All relevant information is subject to verification. Drug screenings and security clearance will be conducted on prospective applicants being given serious consideration for employment and whose job requires direct contact with clients.
